**CITY COUNCIL REGULAR MEETING MINUTES-AMENDED**  
**NOVEMBER 26<sup>TH</sup>, 2013**

Members of the City Council of the City of Crawford, Nebraska, met in regular session in the City Hall Council Chambers, 135 Elm Street, Crawford, Nebraska on the 26<sup>th</sup> day of November, 2013, at 6:30 o'clock p.m. The following individuals were present: Mayor Terrence Haugen, Attorney Adam Edmund, Council Member Dave Kennedy, Council Member Ed Kuhnel, Council Member Karla Adams and Council Member Forrest Peterson. Absent: none.

Notice of the meeting was given in advance thereof by publishing in The Crawford Clipper/Harrison Sun as shown by the affidavit of publication filed in the City Clerk's office at City Hall. Availability of the agenda was communicated in the advance notice and in the notice of the Mayor and City Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mayor Terrence Haugen called the meeting to order and declared a quorum present at 6:30 p.m. and announced to the public that a copy of the Open Meetings Act is posted on the wall in the Council Chambers. It is also available in pamphlet form.

Council Member Kennedy made a motion to approve minutes of the November 12, 2013 regular council meeting. The motion was seconded by Council Member Adams. The following Council Members voted AYE: Kennedy, Adams, Kuhnel and Peterson. Council Members voting NAY: None. Motion carried.

**Board Reports**

**Ponderosa Villa:** no report, due to conflict with Hospital Board meeting.

**Hospital:** audit is in progress; approved a \$.40 raise and beef certificate for employees; Christmas party will be in January

**SWANN:** property on Main Street will not have the lien of \$1700 removed

**Fire:** the wildland-fighting equipment is also used on dumpster fires and in the city limits

**Library:** submitted minutes from September 10, 2013, the Report of the Librarian and a request for a \$.25 raise for Cleone Hoyda

**Golf, Park, Rodeo:** no report.

The Sheriff's Office reported that the hunting season has gone well this year, only receiving a couple of calls; emergency protective custody on a Crawford resident.

Council Member Adams made a motion to approve the Treasurer's Reports as written. The motion was seconded by Council Member Peterson. The following Council Members voted AYE: Adams, Peterson, Kennedy and Kuhnel. Council Members voting NAY: None. Motion carried.

Council Member Kennedy made a motion to table the hire of Amanda Lager to the next meeting. The motion was seconded by Council Member Kuhnel. The following Council Members voted AYE: Kennedy, Kuhnel, Adams and Peterson. Council Members voting NAY: None. Motion carried.

Council Member Kennedy and Council Member Kuhnel will meet tomorrow at 10:00 a.m. to start the process of analyzing applications.

Council Member Kennedy made a motion to approve a \$.25/hour raise for Cleone Hoyda. The motion was seconded by Council Member Adams. The following Council Members voted AYE: Kennedy, Adams, Kuhnel and Peterson. Council Members voting NAY: None. Motion carried.

Council Member Kuhnel made a motion to approve the return to Walmart of the \$1,000 donation for a youth center. The motion was seconded by Council Member Adams. The following Council Members voted AYE: Kuhnel, Adams, Kennedy, and Peterson. Council Members voting NAY: None. Motion carried.

Council Member Peterson made a motion to approve and accept the bid by Tree Doc for hazard tree removal and stump grinding. The motion was seconded by Council Member Adams. The following Council Members voted AYE: Peterson, Adams, Kennedy and Kuhnel. Council Members voting NAY: None. Motion carried.

Tony Storbeck presented the BNSF request for access to 423.

Council Member Kuhnel made a motion to proceed forward with the legal description and a draft of a permanent easement to grant BNSF access to 423. The motion was seconded by Council Member Kennedy. The following Council Members voted AYE: Kuhnel, Kennedy, Adams and Peterson. Council Members voting NAY: None. Motion carried.

Crawford Helping Hands, Inc. will be in charge of the possible railroad tie fundraiser.

Council Member Kennedy made a motion to approve the CWSRF claim of \$277,458 for Hydro Construction and the CDBG claim of \$34,153 for Hydro Construction. The motion was seconded by Council Member Kuhnel. The following Council Members voted AYE: Kennedy, Kuhnel, Adams and Peterson. Council Members voting NAY: None. Motion carried.
