CITY COUNCIL SPECIAL MEETING MINUTES MARCH 3, 2014

Members of the City Council of the City of Crawford, Nebraska, met in special session in the City Hall Council Chambers, 135 Elm Street, Crawford, Nebraska on the 3rd day of March, 2014, at 5:00 o'clock p.m. The following individuals were present: Mayor Terrence Haugen, Council Member Dave Kennedy, Council Member Ed Kuhnel and Council Member Karla Adams. Council Member Adams made a motion to approve advertising for seasonal golf maintenance and seasonal clubhouse employees. The motion was seconded by Council Member Kennedy. The following Council Members voted AYE: Adams, Kennedy and Kuhnel. Council Members voting NAY: None. Motion carried.

Council Member Kuhnel made a motion to approve the hire of Denee Limbach as Golf Clubhouse manager. The motion died for lack of a second. Since it was unclear as to why the Golf Board wanted to start the position so early, it was tabled until the March 11th regular council meeting.

Council Member Kennedy made a motion to adjourn at 5:28 p.m. The motion was seconded by Council Member Adams. The following Council Members voted AYE: Kennedy and Adams. Council Members voting NAY: Kuhnel. Motion carried.
