CITY COUNCIL SPECIAL MEETING MINUTES

DECEMBER 14TH, 2015

Members of the City Council of the City of Crawford, Nebraska, met in special session in the City Hall Council Chambers, 135 Elm Street, Crawford, Nebraska on the 14th day of December, 2015, at 5:00 o'clock p.m. The following individuals were present: Mayor David Nixon, Council Member Ed Kuhnel, Council Member Karla Adams, Council Member Skip Chubb and Council Member Roy Norgard. Absent: Attorney Adam Edmund.

Notice of the meeting was given in advance thereof by publishing in The Crawford Clipper/Harrison Sun as shown by the affidavit of publication filed in the City Clerk's office at City Hall. Availability of the agenda was communicated in the advance notice and in the notice of the Mayor and City Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mayor Nixon called the meeting to order and declared a quorum present at 5:00 p.m. and announced to the public that a copy of the Open Meetings Act is posted on the wall in the Council Chambers. It is also available in pamphlet form.

The December 14, 2015 special council meeting recessed at 5:25 pm.

The December 14, 2015 special council meeting reconvened at 5:30pm.

Council Member Adams made a motion to approve Tabbott Sauder as the Street Supervisor. The motion was seconded by Council Member Norgard. The following Council Members voted AYE: Adams, Norgard and Kuhnel. Council Members voting NAY: Chubb. Motion carried.

Council Member Adams made a motion to approve a six-month probation period for Tabbott Sauder as Street Supervisor, with two months already applied, and a 3% raise at the end of the probationary period. The motion was seconded by Council Member Norgard. The following Council Members voted AYE: Adams, Norgard, Kuhnel and Chubb. Council Members voting NAY: None. Motion carried.
